- Know the location of your nearest fire extinguisher and first aid kit.
- Don't indulge in fooling or practical jokes.
- Be aware of evacuation and emergency procedures in your work place.

# Trade Aid Shop Trusts Contractor policy

- All contractors must be aware of the Health and Safety Policy before commencing any work.
- A Contractors Register will be kept and must be completed for all contractors undertaking work for the Trust.
- The Contractors Register is located in the office and is to be completed by the Shop Manager.
- Contractors are expected to wear or use any protective equipment necessary for the safe operation of their work. Safety guards must be in place and used on all machinery operated by contractors.
- Any injury sustained while conducting work for Trade Aid
   ......Shop must be reported to the Shop Manager as
   soon as possible.

#### Reporting of accidents and near misses

- All work related accidents, other than minor cuts and scrapes, must be recorded in the Accident Register.
- Accidents resulting in injury, incidents where serious harm could have resulted must be recorded.
- These will be investigated to ensure that corrective action is taken.
- Near misses should be recorded to assess the risk they pose in order to prevent an accident happening in the future.
- Should a serious harm accident occur management is to advise OSH as soon as possible. **This is a legal requirement**.

### Hazard identification and management

- All hazards or potential hazards must be reported to management.
- A hazard register will be maintained that lists known hazards and the control measures applied.

All reported hazards or potential hazards will be investigated to assess their significance and added to the hazard register if necessary.

#### Visitor policy

Visitors who have approval to be in the workplace must be supervised at all times. Before entering the workplace all visitors must be made aware of

Any hazards that may affect them.

- The location of emergency exits.
- The location of the assembly area.

In the event of an emergency evacuation all visitors must be escorted to the assembly area and accounted for.
